Belle II PXD collaboration organization

18 May 2009

The collaboration is organized around the PXD Institute Board (PXD IB) and 3 persons (Project leader, Technical coordinator and Integration coordinator)

Institute Board

The PXD IB is composed of one representative per each participating institute. The list of participating institutes is in the Annex I Project Leader, Technical Coordinator and Integration coordinator are ex-officio non-voting members.

IB is chaired by the IB chair.

IB chair is elected by the IB from its members. The term of office is 2 years renewable once. The election procedure is defined in the Annex II

IB approves admission of new institutes.

Project Leader

- The Project leader (PL) is the person directly and ultimately responsible to the Belle II PXD
 collaboration (PXD) for execution of the PXD project.
- PL is elected by and reports to the PXD Institute Board
- The term of office is 2 years, renewable
- PL represents PXD in the Belle II collaboration and to the outside
- PL prepares all design decisions, by initiating and preparing all necessary discussion
- PL keeps PXD community informed on developments from the Belle II coordination relevant to PXD
- PL ensures that the PXD status is regularly communicated to the Belle II management
- PL is responsible for organizing the preparation of PXD documentation needed for Belle II documents
- PL ensures a correct distribution and balance of responsibilities among the participating institutions.
- PL brings to the PXD IB attention any incompatibilities or short-fall between what is required for the project execution and the available resources.
- PL negotiates with institutes interested in joining the project, identifies possible contributions and brings proposals to the IB for approval
- PL organizes the project meetings
- PL chairs the PXD IB
- PL ensures the project is represented in scientific conferences, initiates abstract submissions and speaker selection. This task is advised to be delegated
- PL proposes PXD Technical Coordinator to IB for approval
- PL can delegate certain duties to other members of PXD
